



South Carolina Equine Park 2009 SPONSOR INFORMATION

In May of 2009, Kershaw County purchased Camden Equestrian Center, (formerly Westfall Arena and Tri-Color Arena) then leased the facility to the South Carolina Equine Promotion Foundation (SCEPF.) The SCEPF is a non-profit organization that leases and manages the facility now officially named the *South Carolina Equine Park* located on Cleveland School Road in Camden, South Carolina.

The facility was purchased by Kershaw County with funds donated to the county for that purpose. Neither the taxpayers of Kershaw County nor South Carolina have incurred any cost due to the purchase of the facility or the improvements that have already been made. In fact, Kershaw County and the State of South Carolina stand to gain millions in revenue from the operation of the park and the horse and tourism industry it will promote. The facility also provides an enormous social benefit to the community and its families. We have already booked seven events this year, expect to book an average of two per month in 2010, and hope to have a full schedule by 2011.
